By-Laws

By-Law 1

Use of the Club Courtesy Bus or Courtesy Vehicle

- a) Members who wish to use the Club Courtesy Bus or Courtesy Vehicle must be genuine patrons of the Club.
- b) The Club Courtesy Bus or Courtesy Vehicle must only be used when travelling to and from your place of residence or your local accommodation (i.e. caravan park, motel, AirBnB, etc).
- c) The Club Courtesy Bus or Courtesy Vehicles are not to be used to get a ride to and from your home for purposes other than visiting the Club.
- d) When using the Club Courtesy Bus or Courtesy Vehicle you may be asked to provide evidence you have made purchases at either the bar, bistro, café or bottleshop.
- e) You must complete 30 minute minimum stay at the Club to be eligible to use the Club Courtesy Bus or Courtesy Vehicle.
- f) This by-law will be enforced at the discretion of the duty supervisor.
- g) Any member who breaches this by-law may be liable for suspension from the Club or have the Club Courtesy Bus or Courtesy Vehicle privileges cancelled.

By-Law 2

Membership of The Club

- a) All person (excepting minors) entering the Lightning Ridge District Bowling Club must become members of the Club.
- b) Those person/s becoming members who live within a 100-kilometer radius of Club (including Collarenebri, Walgett, Cumborah and Goodooga) must join as Associate members or Full Voting members.
- c) Those person/s becoming members who live outside the 100-kilometer radius of Club may join as either a Visiting member, Associate member, or Full Voting members.
- d) A person shall not be admitted as a Full Voting member, an Associate member, Visiting member or Junior member of the Club unless that person is elected to membership by the Board of the Club, or by a duly appointed election committee of the Club.
- e) The Board may reject any application for membership without assigning any reason for such rejection.
- f) Those persons who have their membership application rejected will not be eligible to reapply for membership until 12 months have elapsed since their most recent membership application was rejected.

By-Law 3

Renewal of Membership

- a) All person wishing to remain a member of the Club must pay their membership dues either annually or at any other time as prescribed by the Club.
- b) A person shall not be renewed as a Full Voting member, an Associate member, Visiting member or Junior member of the Club unless that person is approved to renew their membership by the Board of the Club, or by a duly appointed election committee of the Club.
- c) The Board may reject any application for renewal of membership without assigning any reason for such rejection.
- d) Those persons who have their membership renewal rejected will not be eligible to reapply for membership until 12 months have elapsed since their most recent membership renewal was rejected.

By-Law 4

Minors on the Premises

- a) Minors (any person/s under the age of eighteen years of age) must always remain in the company of a responsible adult whilst on Club premises.
- b) Minors must not remain on Club premises past the hours of 9.30pm on Sunday through to Thursday and past 10.30pm on Fridays & Saturdays.
- c) This by-law will be enforced at the discretion of the duty supervisor.

By-Law 5

Photos of Members

- a) All persons wishing to become or remain members of the Lightning Ridge District Bowling Club Ltd must agree to have photo taken and recorded.
- b) You may be required to update your photo each time you renew and failure to allow the staff to do this may lead to your membership application or renewal application to be rejected.
- c) The photo must record your entire face from the bottom of your chin to the top of your forehead and both edges of your face.
- d) All hairstyles, headwear and any other accoutrement must be adjusted so that your face is fully visible in the photo.
- e) The Board may waive this by-law for individual members at its absolute discretion without assigning any reason for granting the waiver.
